(hereinafter referred to as "ZA-FCAV"), IATF certification certificate, certificate of conformity (Loc), ZA-FCAV certification mark and IATF accreditation mark (hereinafter referred to as "certification certificate and mark"), prevent misuse and misleading publicity, and maintain the reputation of ZA-FCAV. The relevant departments of the ZA-FCAV and the certified organization shall comply with this procedure when using the IATF certificate and logo.</p> <p>Note: This document is applicable to the management of IATF 16949 certification certificates, LoCs and certification marks. When IATF 16949 is added with ISO 9001, the management of ISO 9001 certification certificates and certification marks shall follow the company document "Certification Certificate and Mark Management Procedure" (ZAZH-CX017-2019).</p> <p>2 Responsibilities</p> <p>2.1 The certificate issuer is responsible for issuing the IATF certificate.</p> <p>2.2 The technical department is responsible for the management of certification certificates and logos, and is responsible for the preparation and printing of preliminary/re-certification/transfer certification certificates and certificates of conformity (LOC).</p> <p>2.3 The project leader is responsible for the printing and issuance of certificate</p>

4 Definitions

4.1 IATF Logo: A graphic used by the IATF to a contracted certification body to indicate its specific accreditation status.

4.2 ZA-FCAV Logo: A unique logo (as shown below) is used to indicate the unique identity of ZA-FCAV



4.3 IATF Certification Mark of ZA-FCAV: A graphic granted by ZA-FCAV for use by a certified organization indicating its qualification for certification of a quality management system for the automotive industry (IATF 16949). The style, graphics and text of the graphic comply with the relevant requirements of the "Measures for

4.4 Scope of Certification: A quality management system certified by a certification body, including the applicable customer premises and their associated functions, processes and automotive products.

4.5 Certificate Scope Statement: The statement shown on the IATF 16949 certificate or certificate of conformity, reflecting the manufacturing process under the quality management system and, where applicable, product design responsibilities. The certificate scope statement may also include the category of automotive products produced by the customer.

4.6 Certification Structure: Configuration of all relevant customer manufacturing sites and, where applicable, stand-alone remote support sites included in the IATF

4.7 认证撤销: 机构在技术评审后, 作为一种制裁措施, 根据本规则的明确要求, 撤销客户的认证并使其证书失效。

5 IATF 16949 认证证书及管理要求

5.1 IATF 16949 认证证书是公司颁发给 IATF 16949 认证受审核方, 证明其汽车行业质量管理体系符合 IATF 16949 标准要求的, 带有 IATF 标识和唯一 IATF 编号的明文件。

5.2 在初次、转移或再认证审核后做出肯定的认证决定后, 向客户颁发证书。证书模板由技术部编制并联系 IAOB 批准后使用。

5.3 IATF 16949 认证证书内容包括:

- a) 被认证的制造现场名称、其完整地址、邮编、统一社会信用代码(证书首页), 以及在完整地址下方列出的 IATF 唯一现场识别码(USI);
- b) 扩展制造现场的名称和完整地址, 以及地址下方的 USI, 并在证书第一页进行交叉引用;

4.7 Revocation of Certification: After the technical review, the Institution revokes the Client's certification and invalidates its certificate as a sanction in accordance with the express requirements of these Rules.

5. IATF 16949 certification and management requirements

5.1 The IATF 16949 certification certificate is a clear document issued by the company to the IATF 16949 certification auditee to certify that its automotive industry quality management system meets the requirements of the IATF 16949 standard, with the IATF logo and a unique IATF number.

5.2 A certificate is issued to the customer after a positive certification decision has been made after an initial, transfer, or recertification audit. The certificate template is prepared by the Technical Department and used after approval by contacting the IAOB.

5.3 The IATF 16949 certification includes:

- a) The name of the certified manufacturing site, its full address, zip code, Uniform Social Credit Code (first page of the certificate), and the IATF Unique Site Identifier (USI) listed below the full address;
- b) Extend the name and full address of the manufacturing site, as well as the USI below the address, and cross-reference on the first page of the certificate;
- c) The name of the remote support site, its full address, the USI below the address, and the support functions provided to the manufacturing site (see Annex 2 – List of Support Functions of the IATF Sixth Edition Rules);

5.17 认证证书的更换和补发

5.17.1 在认证证书有效期内, 发生下列情况之一, 获证组织可向 ZA-FCAV 提出换证申请:

- a) 证书持有者变更;
- b) 扩大或缩小认证范围;
- c) 组织所在地变更;
- d) 认证依据的标准改变或换版;
- e) 发现证书信息错误;

5.16.5 The information reporter is responsible for entering the certificate information into the IATF database, and the certificate should be released to the customer within 7 calendar days of the certification decision. The certificate shall be entered into the IATF database within twenty (20) calendar days from the date of entry of the certificate information. When a certificate is modified, the modified certificate shall be uploaded to the IATF database within twenty (20) calendar days.

5.16.6 Certificates uploaded to the IATF database should:

- 1) Be at least in English;
- 2) Include all appendices to the certificate (only 1 document can be uploaded);
- 3) Save in black and white, color or gray;
- 4) Submit as a PDF file (all other types will be rejected);
- 5) No more than 2 MB, including all appendices.

5.17 Replacement and reissuance of certification certificates

5.17.1 During the validity period of the certificate, the certified organization may apply to ZA-FCAV for renewal of the certificate in any of the following circumstances:

- a) Change of certificate holder;
- b) Broadening or narrowing the scope of certification;
- c) change of organization location;
- d) changes or changes in the standards on which the certification is based
- e) Errors in certificate information are found
- f) Loss or destruction of certificates
- g) Other circumstances that require the renewal or reissuance of certificates.

5.17.2 The registration number, year number, serial number and validity period of

Once the customer's manufacturing site meets the eligibility requirements in Article 1.0 of the IATF Sixth Edition Rules and can demonstrate that 12 months of internal or external performance data related to automotive manufacturing have been accumulated, the customer is not allowed to apply for a letter of compliance again and can proceed with the initial certification audit (i.e., Stage 1 Preparation Assessment and Stage 2 Certification Audit). If the initial certification audit is performed by the same certification body that issued the existing Certificate of Conformity, the auditor-days for the Stage 2 certification audit can be reduced by up to thirty percent (30%).

Audit team members who conduct the initial certification audit of the latest Certificate of Compliance may be assigned to the initial certification audit and each surveillance audit for the three (3) year audit cycle.

The last day of the Stage 2 certification audit should be before the expiration date of the existing Certificate of Conformity. If this time is exceeded, the customer should restart the initial certification audit (i.e., the Stage 1 Readiness Assessment and the Stage 2 Certification Audit) and should not reduce the number of auditor days when upgrading from the Certificate of Conformance Letter.

7 Information Notices

7.1 The technical department is responsible for the issuance, suspension, restoration, revocation/cancellation, failure to apply for recertification/new certificate of compliance or upgrade to IATF certification, as well as other change information of the certification certificate/certificate of conformity according to the requirements of CNAS-RC03 "Certification Body Information Communication Rules", and report to

See 5.12.6 and 6.5 for file formats.

8 Requirements for the use of accreditation certificates by certified organizations

8.1 The certification certificate can only be used by the certified organization within its validity period and within the scope of the approved certification, and is not allowed to be transferred, sold, borrowed or fraudulently used in any way.

8.2 Organizations that have obtained ZA-FCAV certification may display their certification certificates on their public publications, promotional materials, web pages, etc., but should ensure that they are clearly legible.

8.3 The certification certificate is valid for three years, and within the validity period, the certified organization can continue to use the certification certificate only after the company's supervision and audit confirms that the registration qualification is maintained.

8.4 The suspension of the IATF 16949 certification certificate is a temporary state and the suspension may result in the reinstatement or revocation of the certificate. During the suspension period, the IATF 16949 certification certificate remains valid and is recognized by the IATF. When an IATF 16949 certification certificate is suspended, the customer shall provide a corrective action plan within a maximum of twenty (20) calendar days after receiving notice of suspension. When revoking or canceling the certification qualification, the use of the certification certificate shall be stopped. When the certification qualification is revoked, the certification certificate is returned
